## **REPORTS**

Technical Advisory Committee: No Report.

Executive Director Report: Jeff Troyer reported that all news publications in Calhoun County posted notice regarding the Public Forums scheduled to present the 'Funding the Future' presentation. Many of the notices will run for multiple days. The presentation dates and locations are: June 14, 2011-Pennfield Middle School cafeteria 5 p.m.-7 p.m., June 15, 2011-Springfield Farmers Market 7 p.m. - 9 p.m., June 16, 2011 Starr Commonwealth Mawby Auditorium 7 p.m. - 9 p.m., June 20, 2011-Newton Township Hall 7 p.m.-9 p.m., June 21, 2011-Marshall Public Service Building 7 p.m.-9 p.m., June 22, 2011, Tekonsha Township Hall 7 p.m.-9 p.m.

A discussion was had about how the Authority would bill governmental agencies for dispatch services and the impact on the local unit.

Jeff presented the statistical data from the severe storm that occurred on May 29<sup>th</sup>.

#### **OLD BUSINESS**

MERS Update – Jeff Troyer distributed the copies of the MERS Joint Transfers Agreement for each municipality. If CCCDA board approves, there will be some minor changes to these documents that will be reported to MERS.

A motion was made by Brent Williams to approve the Joint Transfer Agreements to include corrections to CCCDA's name and the year on the date line. It was seconded by Susan Baldwin. All in favor; motion approved.

PMDC Licenses – This issue had been tabled at last month's Governing Board Meeting. Jeff Troyer stated that he met with FD representatives and the vendor who was awarded the RFP. It

appears that the MDCs will be installed by the end of 2011. Jeff would like to wait to purchase the PMDC software licenses until all MDCs have been installed since the first year's maintenance will begin at the time of purchase.

A motion was made by Steve Frisbie and seconded by Brent Williams to authorize Troyer to purchase the additional 13 PMDC licenses for the fire service once the MDCs have been installed.

All in favor; motion approved.

#### **NEW BUSINESS**

Out of State Travel Authorization – Troyer advised that he has been asked to represent the Michigan Chapter of APCO (Association of Public-Safety Communications Officials) at the National APCO Conference in Philadelphia. This includes representing Michigan at the Executive Council Meetings prior to the actual conference. It will require him to be out of state from August 4<sup>th</sup> through the 10<sup>th</sup>. All expenses will be paid/reimbursed by the Michigan Chapter of APCO.

Steve Frisbie made a motion to approve the out of State travel request with the understanding that all expenses will be reimbursed by Michigan Chapter of APCO. Brent Williams supported the motion.

All in favor; motion approved.
