EXECUTIVE DIRECTOR'S REPORT

Executive Director Troyer reported on the following items:

- Employment Jeff stated that all of the full time positions are currently filled and only one part time position is vacant. The two new trainees have started (Brandie Whitford 7/21 – Mary Kirby 7/27). Erica Nageldinger and Helen Ure are currently in the shadowing phase of training and will be released to work on their own starting August 24th.
- 2. **CCCDA Facebook Page** Jeff reported that the CCCDA Facebook page is still being designed by Haley. Rich has identified a core group of individuals to participate and manage the

Facebook page. Many of the Dispatch Supervisors and six (6) dispatchers will continue to work on this project.

3. **Text to 911** – Jeff reported that he has reviewed a couple of very good products (web based solutions and web browser based solutions) that are rather inexpensive. He stated that not every dispatch console will need to be outfitted with Text to 911. It is recommended that there be a dual point of access for internet connectivity for web browser based solutions. Jeff stated that they are still evaluating a back door solution for the internet connectivity. There is one county in Michigan that currently uses Text to 911.

OLD BUSINESS

1. 2014 Budget Amendment – Revision II

A motion was made by Jeff Albaugh, seconded by Brent Williams to authorize CCCDA Counsel Richard Lindsey to meet with City of Battle Creek Counsel to discuss any issues with paying the remaining balance of the loan.

NEW BUSINESS

1. MOA – Michigan State Police and CCCDA for Access to CCCDA Applications

Jeff provided everyone on the board with a Memorandum of Agreement between the Michigan State Police and CCCDA for access to CCCDA Applications (CAD and MCT). There is no additional cost obligation with this MOA. It provides written documentation to allow MSP to access our MCT/CAD system. CCCDA Counsel Richard Lindsey has reviewed the agreement. Executive Director Troyer is recommending approval of the MOA.

A motion was made by Steve Frisbie, seconded by Brent Williams to approve the Memorandum of Agreement between the Michigan State Police and CCCDA for access to CCCDA Applications as presented.

2. Sharing Administrative Staff and Services

Sheriff Saxton reported that St. Joe County has recently contacted CCCDA about the possibility of sharing Administrative services between the two entities. St Joe County has recently loss their

Executive Director and Deputy Director. Steve Frisbie stated that he thinks that it would be a great opportunity to explore sharing resources between the two entities. Lt. Coleman stated that St. Joe County does have a lot of problems and does need a lot of help. They are looking for Administrative help until they are able to hire a full-time Director.

A motion was made by Brent Williams, seconded by Steve Frisbie to authorize the Executive Director to discuss Administrative Services with St. Joe County.
