Call for Service Formula Service User Costs for First Quarter 2014

This packet is distributed to all service users in accordance with the Calhoun County Consolidated Dispatch Authority's (CCCDA) Call for Service (CFS) Formula Implementation Guidelines; Section III – CCCDA Annual Budget. The contents include a copy of the 2014 PROPOSED Budget and a copy of the CFS Formula Implementation Guidelines for your reference.

CCCDA encourages service user feedback regarding the 2014 PROPOSED Budget contained herein. Questions, concerns, and comments may be submitted in person at the public hearing scheduled for December 10th at 3:05 p.m., and/or in writing prior to the public hearing at CCCDA, 315 W. Green St., Marshall, MI 49068 or via email to jtroyer@calhouncountymi.gov.

As part the 2014 PROPOSED Budget, the amount of revenue to be generated by the CFS Formula next year is \$2,469,000 (\$617,250 per quarter). Each service user's percent of total average CFS will remain the same for the first quarter of 2014 (Section V, #2 of the CFS Formula Implementation Guidelines). The table below identifies:

- Each service user's calculated percent of total average CFS (orange column)
- Each service user's quarterly cost for 2013 (green column)
- Each service user's 2014 first quarter (Jan Mar) actual cost if the 2014 PROPOSED Budget is approved (blue column)
