EXECUTIVE DIRECTOR'S REPORT

Executive Director Troyer reported on the following items:

- 1. **County Fire Simulcast System** Director Troyer stated that all of the tower work is complete. The new antennas and microwaves have both been installed. We are working on a little bit of loss of coverage at the Central site with the switch out to the new antenna. The tentative go live date for the cut over to the new simulcast system is January 21st.
- 2. Public Education and Relations Committee (PERC) Director Troyer reported that the PERC group has many dates scheduled to attend several different schools along with the Calhoun County Sheriff's Department. This year's presentation will be "Are You Smarter than a Deputy".
- **3. CFS Recalculations** After the first of the year within ten days the CFS formula has to be recalculated. The recalculations have been done and were sent out to all municipalities electronically on Friday, January 9th and then via mail on Monday, January 12th. Director Troyer stated that if any Governing Board members receive questions from any municipality/service user to encourage them to call him with their questions.

1. Southern MI PSAP Alliance – Letter of Understanding – This Letter of Understanding (LOU) establishes a partnership between Southern Michigan PSAPs to release an RFP to hire a consultant to make recommendations for an ESINet and assist in the design of a Next Generation 9-1-1 CPE project. This agreement establishes CCCDA as the lead agency and established guidelines by which all participating entities must opt in or out of the project after bids are received thus obligating that entity to their share of the costs. Corporation Council Lindsey drafted this agreement and agreed to all change requests from other entities.

Director Troyer recommends approval of the LOU.
