EXECUTIVE DIRECTOR'S REPORT

Executive Director Troyer reported on the following items:

1. County Fire Simulcast System – Director Troyer stated that on January 22nd the go live for the first phase of the County Fire Simulcast System was a success. To date everything sounds fantastic and we have had no complaints regarding the new system. Albion Township, City of Albion, and Sheridan Township are now receiving pages in areas that they did not before.

Director Troyer also stated that plans are in the works for adding the Tekonsha and Athens tower sites as part of Phase II of the County Fire Simulcast System. Director Troyer has been working with Roe Comm. and Tekonsha Village Water Department to put together a plan for the Tekonsha Water Site. Jeff stated that he is hoping to get a written proposal to the Village

of Tekonsha by the end of this month. This proposed plan would eliminate the Girard Tower Lease Site.

- 2. Text to 9-1-1 Director Troyer stated as of February 11th we will be completely through the provisioning phase of Text to 9-1-1 and will be transitioning into a text ready state. However, this does not mean that our center will be able to receive live text but allows us to start testing with all service providers in our county. This is the last step before go-live with Text to 9-1-1.
- **3. 2014 Budget Year-End** We are still receiving receipts from last year's final quarter surcharge. Director Troyer will provide a 2014 year-end budget update at March's meeting. The audit has been scheduled for April 15th-17th.
- **4. Northern Michigan ESINET Meeting** Director Troyer reported that we have received an invitation to attend the Northern Michigan ESINET meeting on Tuesday, March 3rd in Gaylord. They have invited all of their local entities, elected officials, and Governing Board members to attend the event. Several industry professionals (Intrado, Indigital, and Peninsula Fiber Networks) will be in attendance to provide presentations. Director Troyer will provide all Board Members with a detailed agenda once he has received it.
- **5. State 9-1-1 Spring Technology Forum** The spring State 9-1-1 Technology Forum will take place on March 18th at the State of Michigan General Office Building in Lansing. The event will begin at 9:00 a.m. and anyone from the Board is welcomed to attend. Director Troyer will provide the Board with the agenda once it has been finalized.

NEW BUSINESS

 2015 Call for Service Formula Recalculation – Director Troyer provided the Governing Board with revised statistics and an explanation as to why the Call for Service Formula statistics for 2014 had to be recalculated. These statistics will be incorporated into the percent of total average calls for service. These will be distributed in MEMO format to the service users/municipalities on February 11th.

In addition, Director Troyer recommends approval of the following timeline for service users/municipalities to submit for a 10% cap exemption per the CFS Implementation Guidelines:

- Written Exemption Requests must be received by COB Thursday, March 5, 2015
- Exemption Requests will be considered at the March 10, 2015 meeting

A motion was made by Steve Frisbie to approve the revised timeline for the 10% cap exemption allowed in the CFS Formula Implementation Guidelines. The motion was seconded by Tim Hill.

2. Amendment to Call for Service Formula Guidelines — A general discussion was held in reference to amending the Call for Service Formula Guidelines to include the Nottawaseppi Huron Band of the Potawatomi as a "service user/municipality". By doing so, CCCDA will issue this service user a separate percent total average calls for service as it relates to the Tribal Police Department and events that occur on the Reservation or at the Casino.

A motion was made by Jeff Albaugh to authorize the Director to meet and discuss the possibility of becoming a service user/municipality with the Nottawaseppi Huron Band of the Potawatomi tribe. The motion was seconded by Susan Baldwin.
